Annual General Meeting of APN News & Media Limited: 3 July 2007

The outcome of each resolution put to shareholders at the Annual General Meeting of APN News & Media Limited (together with the information required by section 251AA of the Corporations Act 2001 (Cth)) is:

BUSINESS

1. Re-election of Mr Peter Cosgrove

Outcome: Resolution passed unanimously

The total number of proxy votes exercisable by all proxies validly appointed was 395,871,184.

The resolution was decided by a show of hands.

The total number of proxy votes in respect of which the appointments specified that:

- (a) the proxy was to vote for the resolution was 275,077,031;
- (b) the proxy was to vote against the resolution was 117,716,977;
- (c) the proxy was to abstain on the resolution was 109,215;
- (d) the proxy could vote at the proxy's discretion was 3,077,176.

2. Re-election of Mr Ted Harris

Outcome: Resolution passed unanimously

The total number of proxy votes exercisable by all proxies validly appointed was 395,667,719.

The resolution was decided by a show of hands.

The total number of proxy votes in respect of which the appointments specified that:

- (a) the proxy was to vote for the resolution was 288,271,169;
- (b) the proxy was to vote against the resolution was 104,316,007;
- (c) the proxy was to abstain on the resolution was 312,680; and
- (d) the proxy could vote at the proxy's discretion was 3,080,543.

3. Re-election of Mr Liam Healy

Outcome: Resolution passed unanimously

The total number of proxy votes exercisable by all proxies validly appointed was 395,828,542.

The resolution was decided by a show of hands.

The total number of proxy votes in respect of which the appointments specified that:

- (a) the proxy was to vote for the resolution was 303,046,469;
- (b) the proxy was to vote against the resolution was 89,682,768;
- (c) the proxy was to abstain on the resolution was 149,925; and
- (d) the proxy could vote at the proxy's discretion was 3,099,305.

4. Re-election of Mr Kevin Luscombe

Outcome: Resolution passed unanimously

The total number of proxy votes exercisable by all proxies validly appointed was 395,860,963.

The resolution was decided by a show of hands.

The total number of proxy votes in respect of which the appointments specified that:

- (a) the proxy was to vote for the resolution was 328,804,326;
- (b) the proxy was to vote against the resolution was 63,957,332;
- (c) the proxy was to abstain on the resolution was 119,436; and
- (d) the proxy could vote at the proxy's discretion was 3,099,305.

5. Remuneration Report

Outcome: Resolution passed unanimously

The total number of proxy votes exercisable by all proxies validly appointed was 394,687,350.

The resolution was decided by a show of hands.

The total number of proxy votes in respect of which the appointments specified that:

- (a) the proxy was to vote for the resolution was 366,246,024;
- (b) the proxy was to vote against the resolution was 25,375,051;
- (c) the proxy was to abstain on the resolution was 1,293,049; and
- (d) the proxy could vote at the proxy's discretion was 3,066,275.
