David Coe, non-executive chairman of AEPL said, "Marcus brought a wealth of experience and energy to the AEPL team having been a director since inception and Managing Director since July 2007. Both the AEPL Board and I are very appreciative of his contribution, particularly his oversight of AEPL's investment in IBA Health."
