Lasseters Corporation Limited for voluntary suspension of trading shares
Pursuant to Listing Rule 17.2, we request suspension from quotation of all shares in the company.

We provide the following information:

- (a) The suspension is requested because the directors have become aware that the future trading of the company will be dependent upon the continuation of financial support to the company by its parent entity; that the parent entity will not continue that support to the extent and on the terms presently provided; and that any further support will depend upon discussions to be had with the parent entity regarding the terms and conditions of that support and whether it will be provided. The directors are accordingly unable to provide the market with reliable information regarding the future trading of the company until those discussions are had.
- (b) If granted, it is expected that the suspension will last for a period of approximately one month, whilst the company, and the parent entity, take appropriate financial and operational advice. Any continuation of the suspension will then be dependent upon the nature and effect of that advice.
- (c) It is expected that the suspension will end after the company and the parent entity have taken that advice and agreed a plan of action.
- (d) At the time of making this application, the directors are not aware of any reason why trading in Lasseters shares should not be suspended, and believe that no adverse consequences will result if the suspension is approved.
- (e) There is no other information that the directors consider necessary to disclose to the market in applying for the suspension of quotation of the shares in the company.
