### Renewal of Exploration Licences

Dragon Mountain Gold Limited (DMG) would like to advise that the Exploration Licensing Division of the Ministry of Land and Resources in China has approved the renewal of all of the following exploration licences for the Lixian Project:

DMG subsidiary, Long Province Resources Ltd, holds an 87% interest in Gansu Long Ao Mining Company Limited and a 90% interest in Gansu Long Jin Mining Resources Company Limited.

These licences have all been renewed until 31 December 2010.

Licence Number T01120090202025163 contains an inferred JORC resource comprising 18.9Mt at 1.8g/t Au for 1.1Moz, which is the first in a series of known deposits with potential to be converted to JORC compliant status, within the historical gold producing region in central China, where the Lixian Project is located.

The renewal of the Lixian Project licences is a significant positive step in the application process for the Mining Area Demarcation licence and reinforces DMG's presence in China through the Lixian Project.
