2.6 Brief explanation of figures 2.1 to 2.4

Net results for the year amounted to a loss of \$665,263 attributable to the members compared to a loss of \$331,760 for the same period last year - a variance of \$333,503. The main reason for the increased loss was due to a one off, non-operating expense of \$389,125 which related to the impairment of the Lionel Diggings Exploration Costs. The Directors thought that this was the most prudent course of action which is in line with current accounting standards and the board intention to concentrate more on the company's Lyndon tenements in Western Australia. In that regard and as outlined in previous announcements we have recently completed rock sampling at Lyndon and expect the results within the next 2 weeks.

Operating costs of the company continue to consist mainly of accounting / audit costs, geological consulting fees, legal expenses, listing fees and Directors fees. Year on year our operating loss has reduced by \$56,365.
