Placement raises \$825,000

SER is pleased to announce the successful placement of 33 million new ordinary shares with 'Sophisticated Investors' and 'Professional Investors' at A\$0.025 per share to raise \$825,000. The placement was undertaken at recent market prices, indicating support for the company's current plans.

Subscribers to the placement include new investors, together with additional investment from a number of current shareholders. No costs were associated with the issue. The share issue is within the company's 15% capacity.

The placement will ensure SER is funded to meet our current exploration program and to pursue additional value creating projects. An overview of our plans for the coming year will be presented at the Annual General Meeting on 25 November.
