FURTHER ON MARKET PURCHASE OF CONVERTIBLE NOTES

A wholly owned subsidiary of Dragon Mining Limited (“Dragon Mining” or the “Company”) has purchased a further 189,519 Dragon Mining Convertible Notes (“Notes”) at an average cost of \$1.00 per note for a total of \$190,144 including costs.

Of the 23,645,289 Notes on issue, 12,045,135 Notes are now held by the subsidiary of Dragon Mining. All Notes remain listed on ASX. Dragon Mining intends on holding these Notes until maturity in February 2011 or in special circumstances on-sell some or all of the Notes.
