### **Funding**

On 28<sup>th</sup> January, 2010, the Company has completed a placement of 16,000,000 ordinary shares and raised \$80,000. These funds will be used for general working capital.

### **Debt Conversion**

As announced to the market on 2<sup>nd</sup> December 2009, BPG converted a portion of its debts to equity. Part of the debt conversion is being reflected in the Appendix 4C under Item 1.18 (a reduction of debt of \$795K) and Item 1.15 (Proceeds from share issue).
