PLACEMENT OF SHARES

Indochine Mining Limited (ASX Code: IDC) announces a placement of 7,053,496 ordinary fully paid shares at a price of \$0.30 per share, which raised \$2,116,048.80. The placement was made to clients of broker Empire Securities Group Pty Ltd. The placement was approved at an Extraordinary General Meeting held on 1 June 2011.
