

ISSUE OF MONTEZUMA MINING COMPANY LTD SHARES – SECONDARY TRADING NOTICE NOTIFICATION PURSUANT TO PARAGRAPH 708A(5)(e) OF THE CORPORATIONS ACT 2001 ("Act")

On 13 June 2011, Montezuma Mining Company Ltd ("**Company**") issued 225,000 fully paid ordinary shares at an issue price of \$0.20 each, on 17 June issued 5,000 fully paid ordinary shares at an issue price of \$0.20 each and on 20 June 2011 issued 17,700 fully paid ordinary shares at an issue price of \$0.20 ("**Securities**").

Secondary Trading Exemption

The Act restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A. By the Company giving this notice, sale of the Securities noted above will fall within the exemption in section 708A(5) of the Act.

 - A. *the assets and liabilities, financial position and performance, profits and losses and prospects of the Company; or*
 - B. *the rights and liabilities attaching to the Securities.*
