## AMALGAMATED PEST CONTROL SIGNS CONTRACT WITH MINT WIRELESS FOR MOBILE PAYMENT SOLUTION

- **Mint Wireless has signed a three year contract with Amalgamated Pest Control to use Mint Wireless' mobile payment solution in Australia**
