

EXPLORATION OF ZAMBIA PROJECT COMMENCES

5th September 2012

Chrysalis is pleased to announce it has commenced its exploration programme on its 5 licences in Zambia.

The exploration programme consists of:

- Aeromagnetic Surveys over its 5 Large Scale Prospecting licences in Zambia and
- 4700 metres of RC and Diamond drilling on the Shikila and Kabwima licences in the North of Zambia.
- Satellite Imagery and Ground IPs

Chrysalis' Zambian subsidiary, Sedgwick Resources Limited, has engaged New Resolution Geophysics of South Africa to undertake a helicopter borne magnetic and radiometric survey over its 5 Large Scale Prospecting Licences. The survey has now commenced and will be flown on North South lines 200 metres apart over 16,850 line kilometres at an altitude of 30 metres with East West tie lines 2 kilometres apart.


This survey forms an integral part of the exploration of the Zambian tenements. Structural, stratigraphic models and uranium are considered to be factors associated with deposits such as Kansanshi and Lumwana in the Northern areas and late stage intrusions and haematite associated with the Hook Granite Complex in the Southern areas. Chrysalis believes that the magnetic and radiometric survey will aid in defining these factors and locate prospective areas for follow up.

The drilling programme which consists of drilling 2,000 metres of RC drilling and 700 metres of Diamond drilling at Shikila and 2,000 metres of RC drilling at Kabwima has been signed with Ox Drilling and is expected to commence in the third week of September.

Targets have been identified from historic soil copper anomalies and drainage channel sampling. Limited drilling has highlighted multiple zones of Cu mineralisation. Assays results from the historical drilling were incomplete; however the data provides targets for the current exploration. The exploration program in the Northern areas of the tenement package will target Kansanshi-style high grade crosscutting mineralisation zones.
