BOARD APPOINTMENTS / RESIGNATION and PROPOSED AU\$ 2.5M PLACEMENT

The Company is pleased to announce that Dr Paul D'Sylva and Mr Timothy Morrison have joined the Board of Alcyone Resources Ltd as Directors.

Dr D'Sylva and Mr Morrison have substantial mining and energy capital markets experience through independent advisory firm Empire Equity Limited. At Empire Equity they have funded a diverse range of resource companies in equity, debt and structured financings on a proprietary basis as well as from a network of institutional funding partners.

The Company advises that Managing Director Mr Andrew King has tendered his resignation effective immediately. The Board expresses its appreciation for Mr King's contribution in shaping and advancing Alcyone's position as an Australasian silver mining company. Mr King will continue to work with the Company through a transition period.

PROGRESS AND FUNDING UPDATE

Following a detailed review of the Company's operations and financial position, the Company is pleased to announce that it has signed a non-binding term sheet to raise AU\$2.5 million by way of the placement of promissory notes to an Australian based investment group. Final binding documents are being prepared and the fund raising is expected to close on execution of these binding agreements later this month.

The proceeds from this placement will be used primarily for upgrades and maintenance on key plant and equipment, the continued development and operation of the Company's Texas Silver Mine and for general working capital. The Company is targeting processing of 80,000 tonnes per month in the second quarter with an average head grade of 80 to 100 grams per tonne.

The Company is pleased at the level of interest and support it has received from domestic and international institutional and strategic investors (including its existing lenders). The Board believes that on completion of this fund raising the Company will be well positioned to generate a strong cash flow from operations.
