## Sumatra Announces Key Board Appointment

*Provident Capital Director Gavin Caudle  
appointed as Non-Executive Director*

Sumatra Copper & Gold plc (ASX: SUM) is pleased to advise that it has further strengthened its Board with the appointment of respected Asian focused corporate and finance executive **Mr. Gavin Caudle** as a Non-Executive Director ahead of its transition to gold producer.

Mr. Caudle is Perth born and educated and has over 20 years' experience in the finance and investment sectors in Australia, Singapore and Indonesia. He joins the Board as the representative of Sumatra's major shareholder and cornerstone investor, Provident Capital Partners Pte Ltd.

Since 2003, together with his partners, Mr. Caudle has developed numerous successful businesses in Indonesia including Tower Bersama Group (a telecommunications infrastructure business) and Provident Agro (a plantation business) with assets currently valued in excess of \$4 billion.
