QUARTERLY ACTIVITIES REPORT FOR THE QUARTER FROM 1 JANUARY 2014 TO 31 MARCH 2014 (THE "REPORTING QUARTER")

HIGHLIGHTS

- ◆ The main area of works for this Reporting Quarter was the preparation and submission of the detailed exploration report for iron ore resources at the Silverstone Project (the "<u>Detailed Exploration Report</u>") to the Fujian Provincial Land and Resources Assessment Field Investigation Centre (the "<u>Field Investigation Centre</u>").
- Field exploration during this period was focused mainly on the exploration of the non-metallic ore minerals (quartz veins and feldspar) resources at the northern part of the concession area. Completed one drill-hole ZK30.

Unless the context otherwise permit or otherwise defined, capitalised terms used in this quarterly activities report shall have the same meaning as ascribed to it in the previous quarterly report.

1. <u>Submission of Detailed Exploration Report</u>

During the Reporting Quarter, the Company submitted the Detailed Exploration Report to the Field Investigation Centre. Validation of the Detailed Exploration Report by the Field Investigation Centre is an integral and important part of the application for the Mining Permit.

The Field Investigation Centre completed detailed on-site assessment of the contents reported in the Detailed Exploration Report, and had provided the Company with feedback and comments thereon. Based on their feedback and comments, the Company carried out some minor additional works and made amendments to the Detailed Exploration Report. The Company submitted the amended Detailed Exploration Report (incorporating the feedback and comments received) for final approval.

As of the date of this quarterly activities report, the Company has not received final approval from the Field Investigation Centre.

2. <u>Exploration Works for Non-metallic Materials</u>

During the Reporting Quarter, the Company completed drilling of drill-hole ZK30. Based on the findings of drill-holes ZK20 (completed during the last reporting quarter) and ZK30, the Company completed drilling of additional drill-holes ZK11 and ZK12, and commenced drilling of drill-hole ZK13.

This drilling programme is to investigate the suitability of the materials at this location of the Silverstone Project for the manufacture of architectural slab.

Total expenditure incurred and paid for the exploration works carried out during the Reporting Quarter was A\$113,986.

4. <u>Planned Work Programme for Next Reporting Quarter</u>

Current planned exploration works for iron ore in the tenement area has been completed during the Reporting Quarter. The Company is now waiting for the acceptance of the Detailed Exploration Report (as amended) from the Field Investigation Centre, before submission thereof to the Fujian Province Land Resource Bureau.

Concurrently, the Company will continue to carry on other preliminary exploration works for feldspar and non-metallic ore bodies at the northern and western block-rock zones of the tenement area.
