**ENE Successfully Completes 18 MW Expansion of
Moranbah North WCMG Project**

Energy Developments Limited (ENE or the "Company") is pleased to announce the completion of the 18 MW expansion of the Moranbah North Waste Coal Mine Gas (WCMG) Project, increasing the capacity of the Project to 63MW.

ENE's Moranbah North WCMG Project has been operational since 2008 using WCMG from Anglo American's Moranbah North mine. As announced on 16 August 2013, the 18 MW expansion is underpinned by a 25 year extension of gas supply arrangements with Anglo American, including from Anglo American's new Grosvenor metallurgical coal mine, which is currently under construction.

The expansion of the Project also enables ENE to provide network support services and substantial network capital savings in the Bowen Basin area under a two year Network Support Agreement (NSA) with Powerlink Queensland.

ENE Managing Director Greg Pritchard said "The expanded Moranbah North WCMG Project delivers significant environmental and economic benefits. By utilising WCMG for power generation, this Project abates and avoids about 1.7 million tonnes of CO2 equivalent to removing about 600,000 cars from the roads. At the same time, this Project provides valuable distributed generation and network support services to the mining communities in the Bowen Basin."

"The successful completion of this Project with no reportable occupational health and safety or environmental incidents over more than 35,000 hours worked and two months ahead of the original schedule highlights the Company's position as Australia's leading waste methane to energy generator.

ENE now has 253 MW of WCMG power generation following the acquisition of the 43 MW Envirogen portfolio in April 2014, with further expansion opportunities under active discussion", Mr Pritchard said.

In the year ended 30 June 2014:
