Appointment of New Chairman and New Non-Executive Director

Lynas Corporation Limited ("Lynas") (ASX:LYC, OTC:LYSDY) today announced the appointment of Mike Harding as the new Non-Executive Chairman and Philippe Etienne as a new Non-Executive Director. Both appointments are effective from 1 January 2015.

Also, with effect from 1 February 2015, Nicholas Curtis will stand down after 14 years of service to the Company.

Philippe Etienne is a Non-Executive Director of Transpacific Industries Group Limited and the former Managing Director and Chief Executive Officer of Innovia Security Pty Ltd.

In addition, he was previously Chief Executive Officer of Orica Mining services and was a member of Orica Limited's Executive Committee.

Mr Etienne's career includes senior executive positions with Orica in Australia, the USA and Germany including strategy and planning and responsibility for synergy delivery of large scale acquisitions.

Mr Etienne holds a Master of Business Administration (MBA) and has completed post graduate qualifications in marketing

Mr. Harding commented: "Both Philippe and I are greatly looking forward to our new roles at Lynas. We recognize that Lynas has had its challenges, however we believe Lynas is a Company with significant opportunities. We believe our skills and industry experience, together with those of the existing Directors and the management team, will combine to provide a strong leadership team to assist Lynas to fulfil its potential."
