#### PRELIMINARY NOTICE - PAYMENT OF FINAL INSTALMENT - DUE 15 MAY 2015

1 April 2015

Meridian Energy Limited (MELCA/MEZCA) today despatched to security holders the Preliminary Notice for the Final Instalment of NZD\$0.50 per instalment receipt.

The payment period opens from 6 May 2015 with the Final Instalment of \$0.50 per instalment receipt due on or before 5.00pm (NZ Time) on Friday 15 May 2015.

The Final Instalment Payment date and amount is in accordance with the prospectus and investment statement dated 20 September 2013 and applies to those holders recorded on the register at close of business on 4 May 2015.

NZX have also approved the final day of trading in MELCA being Tuesday, 29 April 2015, prior to the instalment receipts being suspended at close of business.

## Why am I receiving this?

Because as at 30 March 2015, you were the registered holder of Meridian Energy instalment receipts.

There is a Reminder Notice attached that tells you how many instalment receipts you held at that date.

If you continue to be the registered holder of Meridian Energy instalment receipts as at 4 May 2015, you will be liable to pay the final instalment of NZ\$0.50 per share.

#### What do I need to do?

## What are the payment options?



## **Direct debit**

Direct debits will be accepted from 6 May 2015. A secure website will be available which, if you provide your CSN and postcode, will pre-populate vour details and the final amount payable by you. Simply fill out the direct debit information and authority required to allow Computershare to debit your account of the amount owed by you. It is important to note that the money will come out of your account on 15 May 2015. Please ensure your bank account is authorised to accept a direct debit and that there are enough funds in your account on the payment date to cover the amount pavable by you.



## Online banking

Instructions for making a payment by online banking will be made available from 6 May 2015. All payments made by this method must be made by 15 May 2015 to the bank account specified on the final payment notice along with the required reference details. NOTE: Ensure your account settings allow you to make one online payment of the size required. Please do not make multiple payments.



## Cheque

Details on where to send your cheque will be available from 6 May 2015. Cheques will be banked on the date of receipt (from 6 May 2015) and should not be post-dated. Cheques should be mailed in sufficient time so that they are received by Computershare no later than 15 May 2015. ## PRELIMINARY NOTICE- PAYMENT OF FINAL INSTALMENT - DUE 15 MAY 2015 You will be sent a Final Payment Notice closer to the time

We are writing to you because you were registered as a holder of Meridian Energy Limited instalment receipts as at the close of business on 30 March 2015.

Each Meridian Energy Limited instalment receipt corresponds to an ordinary share in Meridian Energy Limited and records the obligation of the holder of the instalment receipt to pay the final instalment of the purchase price for the corresponding Meridian Energy Limited ordinary share (being \$0.50 for each instalment receipt).

The purpose of this letter is to remind you that the final instalment will soon be due for payment and that, if you remain the holder of instalment receipts on 4 May 2015, you will be responsible for paying the final instalment in respect of each instalment receipt held by you on that date.

The last date of trading of the Meridian Energy Limited instalment receipts on the NZX Main Board and on the ASX is expected to be 29 April 2015 with ordinary shares expected to trade on a deferred settlement basis from 30 April 2015. #### What is the difference between direct debit and online banking?

Payment by direct debit can be made by logging on to a secure webpage hosted by Computershare. To log on you will require your CSN and postcode. At this webpage you will be asked to enter your own bank account information and authorise Computershare to debit your account on 15 May 2015. This process guarantees that your payment will go to Computershare on the due date, and it can be completed in advance. You are responsible for ensuring that your bank account settings permit direct debit payments, and that you have sufficient funds in your account on the payment date to cover the amount being paid.

Payment by online banking requires you to log on to your own bank's online banking facility and make a one-off payment, using the account number and reference information provided to you. If you make an error in entering this information the payment may not be successfully received. #### **CONSEQUENCES OF NON-PAYMENT**

If you are registered as a holder of instalment receipts on 4 May 2015, and you do not pay the final instalment in respect of the instalment receipts held by you by 15 May 2015:

- you will remain liable to pay the final instalment and may also be liable to pay additional amounts (such as default interest, certain fees, costs, expenses, and duties and taxes); and
- the Meridian Energy Limited shares corresponding to your instalment receipts may be sold in order to
  recover the final instalment payable in respect of your instalment receipts and the additional amounts
  referred to above. If the proceeds from the sale of those Meridian Energy Limited shares are less than
  the total amount payable by you, you will remain liable to pay the shortfall following the sale.
