APPOINTMENT OF NEW MANAGING DIRECTOR

Tanzanian focussed mineral sands explorer, Strandline Resources Limited ("Strandline" or "Company") is pleased to announce the appointment of Mr Tom Eadie as Managing Director of the Company effective from the 1st of January, 2016.

Mr Eadie, currently a Non-Executive Director of Strandline, will move to the position of Managing Director replacing Mr Hill, who will remain on the Board as a Non-Executive Director. Mr Hill has agreed to work closely with Mr Eadie over the next 6 months to facilitate a smooth transition of roles.

Mr Eadie was previously the Executive Chairman of Jacana Minerals Limited (Jacana) and instrumental in the recent merger of its Tanzanian minerals sands business with that of Strandline's. This follows on from his position as founding Chairman of the highly successful African focussed Australian mining company, Syrah Resources Limited (Syrah), an ASX listed company with a current market capitalisation in excess of \$800 million.

He also serves as the Chairman of Copper Strike Limited, an ASX-listed exploration company. Prior to his work with Syrah, he had 30 years' experience within the junior resources sector and at technical to senior executive levels with major mining companies including Pasminco, Aberfoyle Resources and Cominco. At Pasminco, he held the role of Executive General Manager (Exploration & Technology) for 11 years. At Aberfoyle, he began as Chief Geophysicist, later taking charge of all mineral sands and base metal exploration. He is a past board member of the Australasian Institute of Mining and Metallurgy and of the Australian Mineral Industry Research Association.

The terms and conditions of Mr Eadie's appointment, including remuneration arrangements, will be finalised in due course.

The Directors of Strandline have agreed to review the composition of the Board over the next 3-6 months. The Company intends to reduce the number of Directors on the Board whilst retaining an appropriate skillset to ensure the Company is well positioned to develop its Tanzanian mineral sands projects.
