**EnviroSuite: Thames Water and Odournet update**

**Pacific Environment Limited** (ASX:PEH or “The Group”) is pleased to update the market on its key European and UK activities with EnviroSuite client, Thames Water Utilities (“Thames Water”) and European partner Odournet Group.

As announced to the market on the 15th of March 2016, Odournet UK has introduced PEH into Thames Water, the UK’s largest water and wastewater services company servicing the Greater London region. The Group has commenced work at two of over 30 sites with odour problems owned and operated by Thames Water. PEH team members are working closely with Thames Water to integrate EnviroSuite with operational practices at these two sites.

This initial project, while being commercially significant in itself at \$300,000 over 12 months, has the potential to extend across all Thames Water sites to become a much larger concern for the Group. Furthermore, having seen this initial success of EnviroSuite’s application for one of the world’s most recognised water authorities, the Odournet subsidiaries in Spain and France have been working to procure similar engagements in targeted European cities.

Pursuing these and other opportunities with Odournet forms a key launch strategy for PEH in Europe and the UK with the size of populations, industry and government being far greater than in Australia, where the bulk of EnviroSuite sales have occurred to date.

**Executive Chairman Murray d’Almeida commented that,**

“Partnering with recognised industry incumbents in targeted geographic regions is the primary route to market for EnviroSuite in new territories. We consider that leveraging well-established client networks as well as local knowledge and expertise is an expeditious route to market for the Group as it pursues step growth of the EnviroSuite platform.”
