DGR Business Update

Further to its previous ASX releases, DGR Global Ltd (**DGR, ASX: DGR**) wishes to provide the following update in respect of the bridging loan facility (**DGR Global Loan Facility**) provided to Armour Energy Ltd (**Armour, ASX: AJQ**).

Extension of DGR Global Loan Facility

DGR advises that it has agreed to an extension of the DGR Global Loan Facility to 31 July 2016 (**New Termination Date**). This two month extension has been granted to Armour on the current terms of the facility, which is currently secured and has an interest rate of 15% per annum.

DGR and Armour have executed a Deed of Variation of the DGR Global Loan Facility today.

The facility has been fully drawn to its revised limit of \$13 million.

Third Party Funding Update

Armour continues to progress negotiations with other third party / commercial financiers. The parties will update the market in due course, as and when able to do so.
