Following approval of the Board of Directors, the Company has granted an aggregate of 280,000 options over common stock. The new options include a grant of 100,000 options at a strike price of US\$3.675 to Antony Catalano, a Director of the Company, following approval of Shareholders at the Annual Meeting of Shareholders. The new options also include a grant of 120,000 options at a strike price of US\$7.240 (equivalent to \$AU0.40/CDI) to a new advisor to the Company. The remaining new options are grants to new and existing employees of the Company, at a strike price at or near the ASX market price (in US Dollars). The future exercise of such options could, in the aggregate, result in a significant increase in the Company's cash position. In addition, options over 18,750 shares of common stock have either failed to vest or expired since the previously filed Appendix 3B.

No new Shares of stock have been issued.
