Urbanise secures \$6.8M contract with South Africa's King Price Insurance

With a customer base of over 100,000 consumers - growing at a rate of over 50% year on year - King Price is positioned to significantly expand with the use of the Urbanise platform within the insurance and sectional title (Strata) markets in South Africa.

The deal with Urbanise provides King Price with an exclusive and exciting arrangement for the insurance and sectional title markets in both South Africa and Namibia. As part of this arrangement, Urbanise and King Price will work together to develop a portfolio of innovative solutions that combine hardware, software and super cheap insurance cover.
