iSignthis to provide Ixaris with Digital KYC service to verify UBOs

Anti-Money Laundering (AML) regulations require not only the end consumer to be identified, but also the directors, ultimate beneficial owners (UBOs) and key controllers of entities that act in the delivery chain of AML regulated services. Typically, partners will have their directors and key controllers identified by use of publicly available information, with specialist providers often used to identify UBOs. Whilst these providers can *identify* the UBOs, they are often unable to *verify* the identity of the UBOs.

Ixaris has contracted with iSignthis for the provision of identity verification services of directors, UBOs and key controllers associated with its partners with a fee payable to iSignthis for each identity verified. The verification of customers being issued with Ixaris cards is not within the current scope of the agreement.

Ixaris Head of Compliance, Charlotte Roberts commented "We're pleased to have entered into this agreement and look forward to working with iSignthis for identity verification. Through integration with iSignthis, we expect to be able to streamline and accelerate our onboarding process.
