## Scheme Consideration

The Company has applied to the Federal Court of Australia (**Court**) for approval of the Scheme at a hearing scheduled for 5 September 2016.

If the Scheme is approved by the Court, Atlantic shareholders who hold shares on the Record Date for determining entitlements to receive the Scheme Consideration (Tuesday 13 September 2016) will be paid A\$0.003 cash per share.

Those Atlantic shareholders will be sent the Scheme Consideration on the Implementation Date (Tuesday 20 September 2016).
