While specific details of licensing terms are not disclosed for commercial reasons, the rates were negotiated from the standard Xped licensing cost sheet:

Further to the initial license fee, the agreement includes ongoing maintenance fees payable to Xped.

Xped and Solekai will now commence work together on integrating Xped's technologies into their solutions. Solekai will extend the Xped reach into their customer base that includes major STB, Gateway, and Media Device manufacturers.

Xped and Solekai will collaborate across both their technology and customer engagements. Technical teams are commencing integration of ADRC into specific Solekai solutions targeting customers in Set-Top Box and Gateway business. Concurrently the sales team have begun joint engagement with several existing Solekai customers to promote the ADRC integrated solutions. It is anticipated that the time from Solekai customer agreement to revenue is approximately 9 months.
