## Commentary

### Operations

Byte Power Group Ltd continues to work on current opportunities through its partnership with Wimobilize Singapore Pte Ltd in Australia, New Zealand, Singapore, Malaysia, China, Hong Kong, Macau and Taiwan. The Group closed its first sale in December 2016 in China and is optimistic about the future developments.

BPG continues to explore opportunities amongst the wine distribution businesses within Asia, particularly with its 8 Eagles range.

The Company expects existing trade receivables to continue to support working capital requirements of the Company while it explores further business and sales opportunities.
