## Frankfurt Stock Exchange Cross-Listing

### – For Immediate Release –

DAKOTA MINERALS LTD (“the Company”) (ASX: DKO, FRANKFURT: ORM<sup>1</sup>), is pleased to announce the listing of its common shares for trading on the Quotation Board of the Frankfurt Stock Exchange (Deutsche Boerse AG) under the symbol ORM.

With this listing, the Company’s shares are now cross-listed on the ASX and the Frankfurt Stock Exchange, one of the largest stock exchanges in the world. The Company anticipates the Frankfurt listing will help increase trading liquidity and facilitate investment in the Company by institutional and retail investors across Europe.

The Company will maintain its primary listing on the ASX. David Frances, Company CEO commented: *“We are pleased to announce the listing of our shares on the Quotation Board of the Frankfurt Stock Exchange. The Company is rapidly advancing its lithium strategy in Europe and this is attracting increasing interest from investors in Germany and elsewhere in Europe. The cross-listing is in direct response to this interest and will provide the Company with access to a large number of new potential investors that will help to expand our shareholder base and increase liquidity. A marketing campaign during the next quarter will introduce the Company to a wider audience across Europe.”*

The Frankfurt Stock Exchange is the world’s third largest exchange behind the NYSE and NASDAQ. Over 3,000 international companies are listed on the Frankfurt Exchange and investors directly connected to the Frankfurt Stock Exchange represent 35% of the world’s investment capital
