



## NEW SAMPLING INCREASES POTENTIAL FOR PICCADILLY

- **Larger potential for the Piccadilly mine identified**
- **Significant widths of mineralisation across strike**
- **Significant gold associated with new identified areas other than high grade quartz veins**

Cannindah Resources Limited's (ASX: CAE) recent excavation and channel sampling at the western end of the Piccadilly Mine area has extended the width and length of the zone of gold mineralisation with potentially economic grades. Cannindah has carried out trench excavation and channel sampling, which has returned significant gold grades over several metres across strike, for example channel sample No.8 returned 10.75m @ 6.90g/t Au (see Figure 1, Table 1). Close spaced sampling has shown that the western end of the Piccadilly zone contains high gold grades with numerous rock chip and 1m-2m channel samples in excess of 5 g/t Au over the 120m length of the current excavated slot. The highest gold grade in rock chips of vein material is 79.4g/t Au at the western end and highest grade at the eastern end is 56g/t Au (Figure 1). The gold zone is open to the east and west and is a component of an array of sub-parallel gold lodes that have been mined historically for at least a further 1200m to the east.

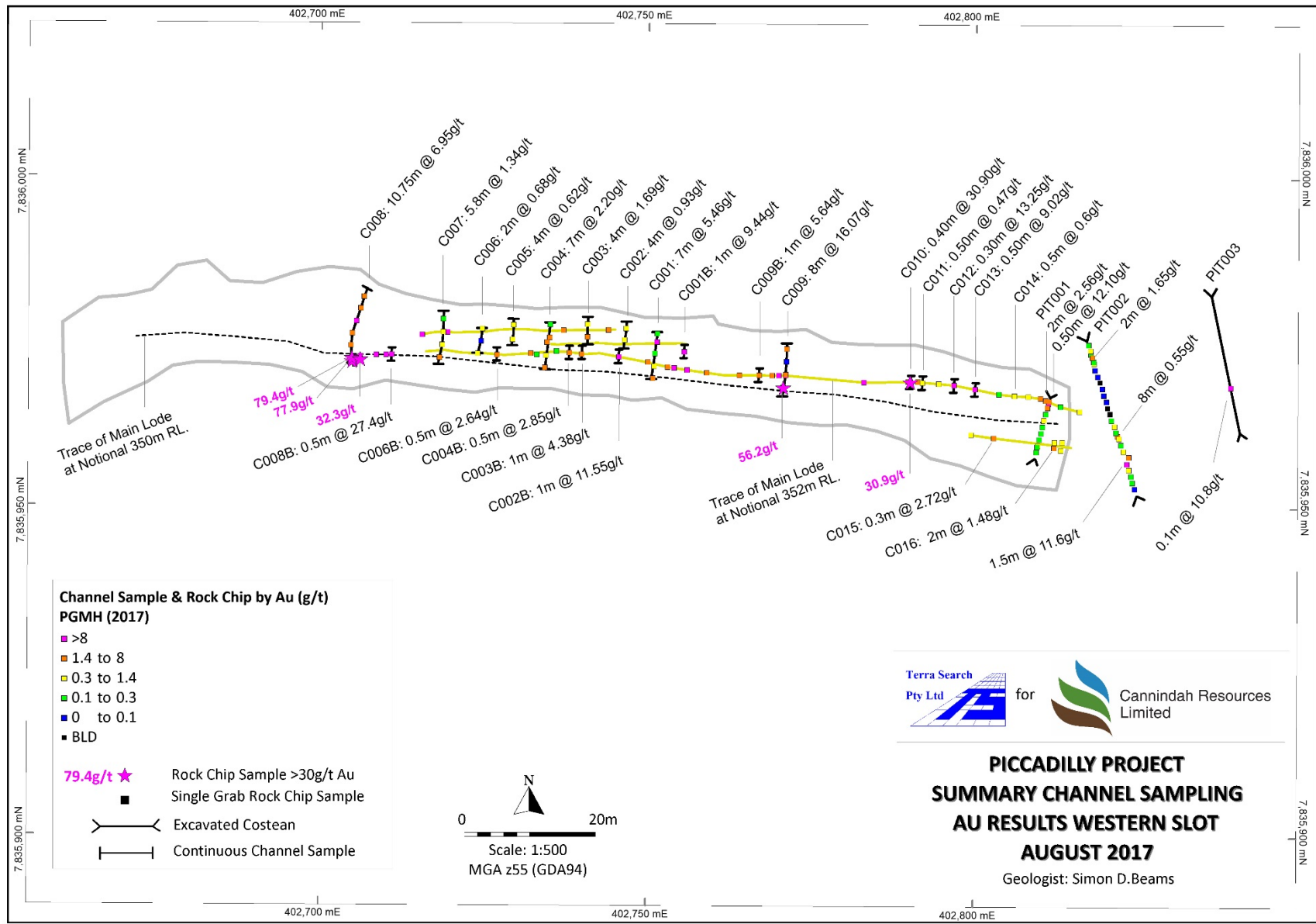
Recent work has shown that in addition to high grade gold occurring in gossanous/sulphide bearing quartz veins, Cannindah has discovered, within the currently trenched area, significant gold associated with carbonate veined and altered host sediments which occur stratigraphically below the main quartz sulphide lodes. Individual rock chip results from these carbonate veined samples have returned up to 3.64g/t Au with channel samples across the zones returning 1m @ 2.56 g/t Au (PIT002), 2m @ 2.58 g/t Au (PIT001) and 4m @ 3.01 g/t Au (C008) (Figure 1). The full significance of the gold in carbonate veined rocks has yet to be evaluated. In another development, sampling of footwall zones sitting below the main comb textured quartz lode, have returned significant widths of mineralisation, in the 4m to 7m @ 1g/t Au to 5 g/t Au range. These new gold zones are characterised by areas of gold bearing material cut by fine gossanous veins and some sulphidic vein breccia infill. These recent discoveries have increased the size potential of the Piccadilly mine, moving the target mineralisation from a narrow focussed, high grade gold vein system to mineralised zones that extend considerable distances into finely veined, altered host rocks.
