Altura Mining Ltd (ASX: AJM) has selected Swift for an initial 12-month term to provide its world class digital entertainment system and Hollywood movie content to Altura's 325-room camp to keep workers informed and entertained.



Altura is building a leading position in the independent supply of lithium raw materials, with a world class lithium project under construction at Pilgangoora and ready to be the first new hard rock lithium product supplier in 2018.
