## Mapping more than doubles area of spodumene-bearing pegmatite swarm at the Buldania Lithium Project, WA

### Highlights

- Multiple pegmatites now defined over a significantly larger area of 1.3km x 2km, compared with the original area of 0.7km x 1.5km indicated by historical mapping.
- Surface dimensions of individual pegmatites measure up to 400m long x 160m wide.
- Previously reported rock chip sampling indicates the presence of widespread spodumene-related lithium mineralization, with assay values of up to 4.6% Li<sub>2</sub>O.
- Initial 3,000-3,300m Reverse Circulation (RC) drill program planned for early 2018, subject to receipt of statutory clearances.

Liontown Resources Limited (ASX: LTR) is pleased to advise that recently completed geological mapping over its Buldania Lithium Project, located ~600km east of Perth in Western Australia, has defined pegmatites over a much larger area than previously indicated by historical exploration.

Multiple pegmatites have now been identified over an area of **1.3km x 2km area (2.6km<sup>2</sup>)**, more than double the previous mapped extent of 0.7km x 1.5km (1.1km<sup>2</sup>) as defined by historical mapping undertaken in the early 1970s.




Figure 1: Buldania Project – Geological plan showing mapped pegmatites and Liantown rock chip samples

Previously reported reconnaissance rock chip sampling by Liontown (see ASX release dated 30<sup>th</sup> October 2017) recorded widespread, high-grade spodumene-related lithium mineralisation (>1.5% Li<sub>2</sub>O/**Figure 1**), with better results including:

Two main target areas have been identified – the **Anna** and **Conda** prospects (**Figure 1**).

The Anna prospect comprises a 550m long, NW-SE trending zone containing a large pegmatite 60-160m in width.

The Conda prospect comprises multiple stacked, SW-NE trending pegmatites up to 200m long and 60m wide at surface.

Limited outcrop exposure means that the true thicknesses of the pegmatites have not yet been determined. It is also possible that many of the pegmatites shown on **Figure 1** are contiguous beneath shallow cover that obscures bedrock.

A maiden 35-40 hole, RC drilling program totalling 3,000-3,300m has been designed to test the main targets as well as a number of thinner pegmatites (10-20m thick) located to the north and east (**Figure 1**). The drilling program is scheduled to commence in early 2018, subject to the receipt of statutory clearances.




Figure 2: Plan showing regional geology, lithium occurrences and Liantown Projects in SE Goldfields

The **Buldanía Project** is located approximately 600km east of Perth in the southern part of the Eastern Goldfields Province, a region well-known for hosting significant lithium deposits including Mt Marion and Bald Hill (**Figure 2**). The Project is also close to major road and rail infrastructure, with direct links to the Port of Esperance, critical to the mining and production of bulk commodities such as spodumene concentrates.

Liontown has entered into an Agreement with Avoca Resources Pty Ltd, a wholly-owned subsidiary of Westgold Resources Limited (ASX: WGX), whereby it has secured the rights to lithium and related metals (which include beryllium, caesium, niobium, rubidium, tantalum and tin) for the Buldanía Project while Avoca retains the right and priority access to all other metals. Avoca will be paid \$2 per tonne for any lithium ore mined and 1.5% of the gross sales receipts.
