



The GO2 People Awarded Stand-Alone Package with ASX-Listed Altura Mining

Highlights

- Wholly owned subsidiary, Terra Firma Constructions Pty Ltd ("Terra Firma") has been awarded a stand-alone package of work worth \$734k with ASX-listed Altura Mining, increasing the total value of works with Altura Mining in FY18 to a total of \$3.55 million
- Terra Firma's scope of works is for a full turn key solution for the expansion of Altura's camp supporting its Pilgangoora Lithium Mine in Western Australia, Terra Firma's scope will be delivered in full by the first week of April 2018
- Demonstrates the diversity and capability of The GO2 People's Building Division offering
- The \$3.55 million total works revenue from this one project alone contrasts with FY17 revenue from the Building Division of \$0.75 million.

The GO2 People Ltd (The Company) is pleased to announce that its wholly-owned subsidiary, Terra Firma Constructions Pty Ltd, has been awarded a stand-alone package of work with ASX-listed Altura Mining Limited ("Altura"; ASX: AJM), increasing the total value of works with Altura in FY 18 by approximately \$734K to \$3.55 million.

The contract is a full turn key solution for the expansion of the camp supporting Altura's Pilgangoora Lithium Mine in Western Australia. The Pilgangoora site is a world-class hard-rock open pit lithium mine which will be in production in 2018. In preparation for production, Altura is putting in place the necessary buildings and infrastructure to make the mine fully operational.

Terra Firma began site works in August 2017 under an initial contract to the value of \$970,000. The stand-alone package announced today, in addition to the prior contract and variations, increases the value of works with Altura in FY18 to \$3.55 million. This current scope of works relates to the design, procurement and installation of facilities and associated works specifically around the Altura Camp, the works have begun immediately and are due for completion in the first week of April 2018.

The Company's Building Division generated revenue of \$0.75m in FY17 and this work, along with others previously announced, highlights the growth of the division in line with the Company's expectations. The Company is aiming to further increase its presence and capability in this sector, in line with its Strategic Plan.
