- Axiom has filed applications in the High Court for judicial review of the Solomon Islands Government's decisions concerning Axiom's applications for prospecting licences for both these deposits. Axiom had previously applied for prospecting licences over these areas and the Ministry of Mines appear to have failed to present these applications to the Minerals Board for formal consideration.
- $\circ~$ The courts have been in vacation until last week. A hearing date is expected to be confirmed by the courts shortly.
