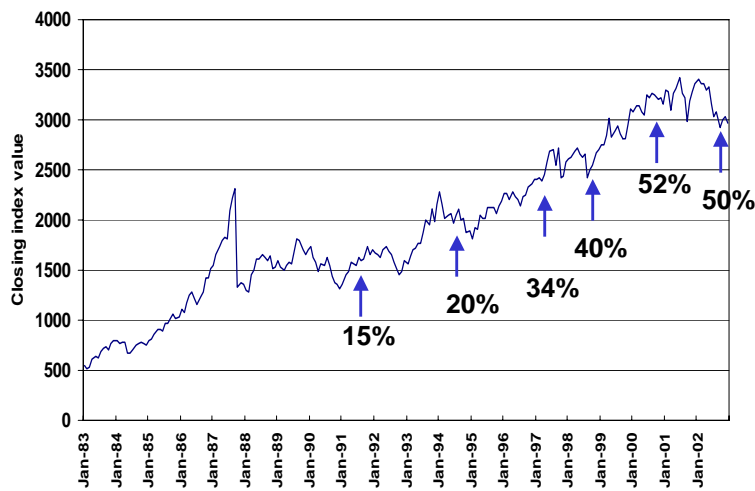

Background

- In November 2002, 2,400 people Australia-wide participated in the ASX Share Ownership Study
- The survey, held on average every 18 months, measures the incidence of share ownership in Australia
- The survey samples sharemarket activity and investor attitudes and tracks shifts in behaviour and outlook
- Assisting the ASX with this research was an independent market research company – Millward Brown Australia
- Survey followed a qualitative study of investor attitudes



Share Ownership - Definition

Direct Share Ownership

Shares in a company listed on a stock exchange, which you **hold directly**, that is, **not** part of a fund

OR

A **direct** investment in a property trust which is listed on a stock exchange

OR

Derivatives such as options, warrants or futures

OR

Listed Interest Rate Securities such as corporate bonds, convertible notes and preference shares

Indirect Share Ownership

An investment in a managed fund that is not part of a superannuation fund

OR

A personal superannuation fund which you have set up but is managed by someone else

OR

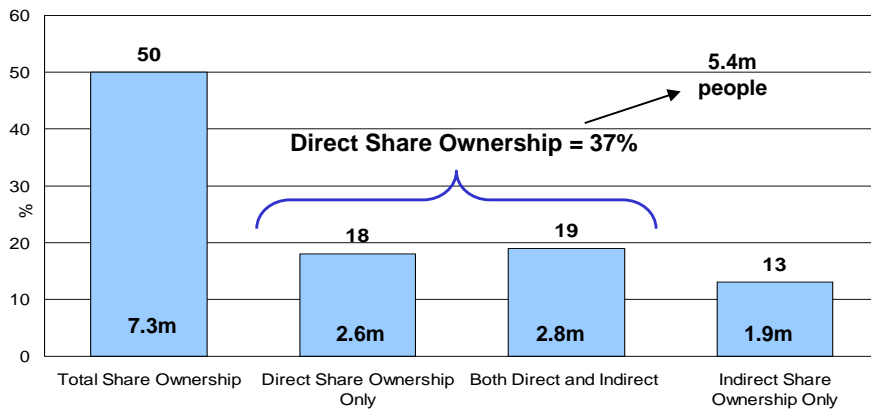
A personal superannuation fund which you have set up and directly manage yourself

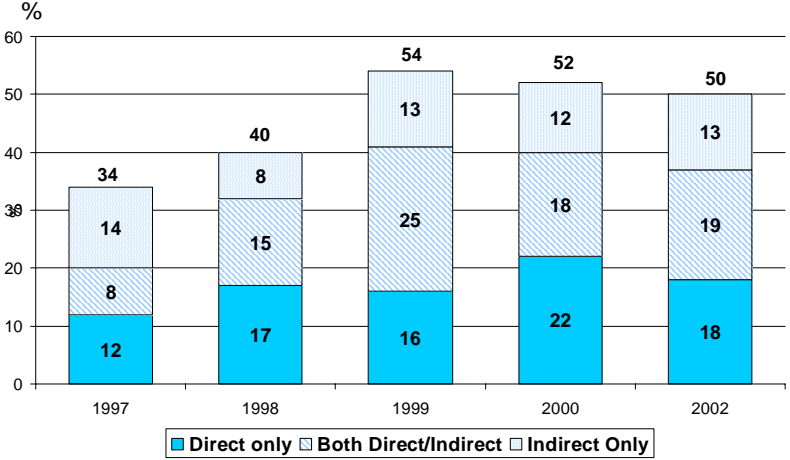

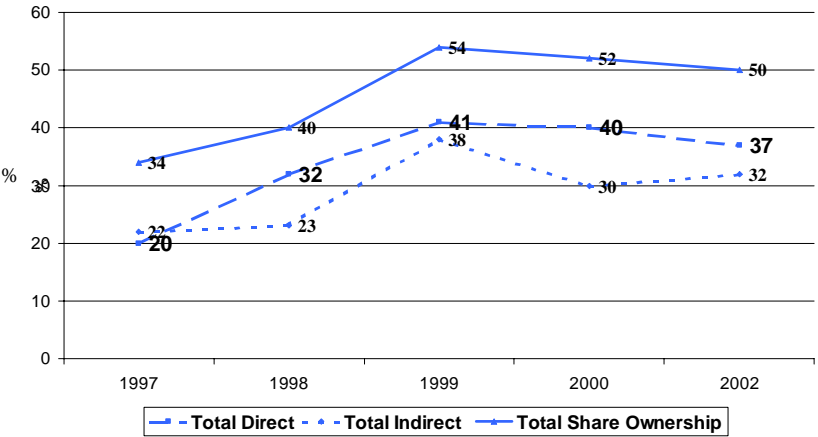
The Trend of Share Ownership

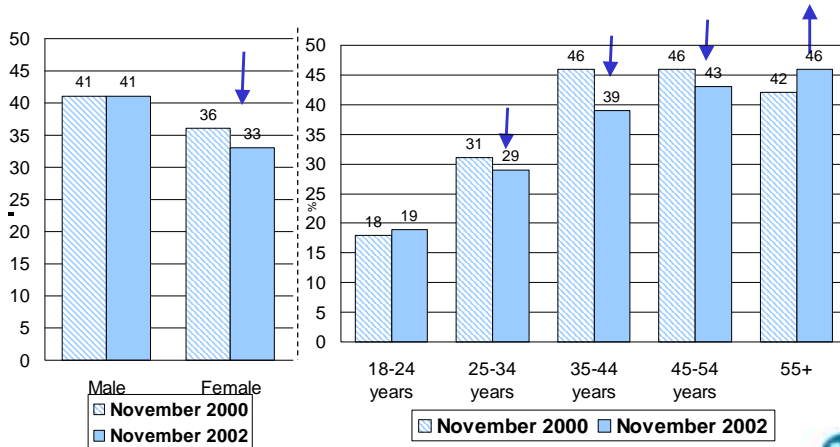

% owning shares directly

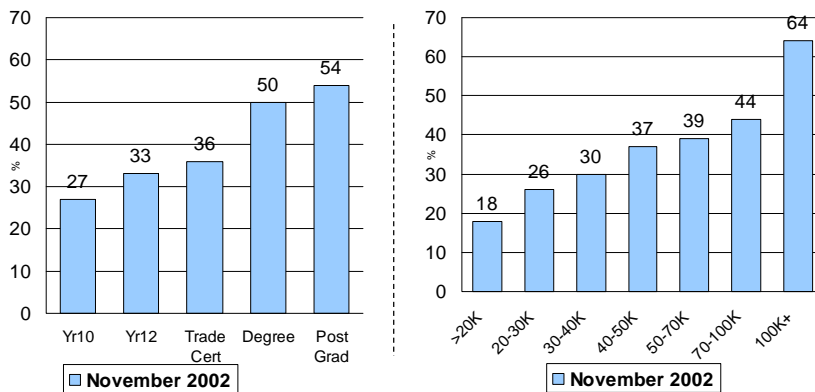

% owning shares directly

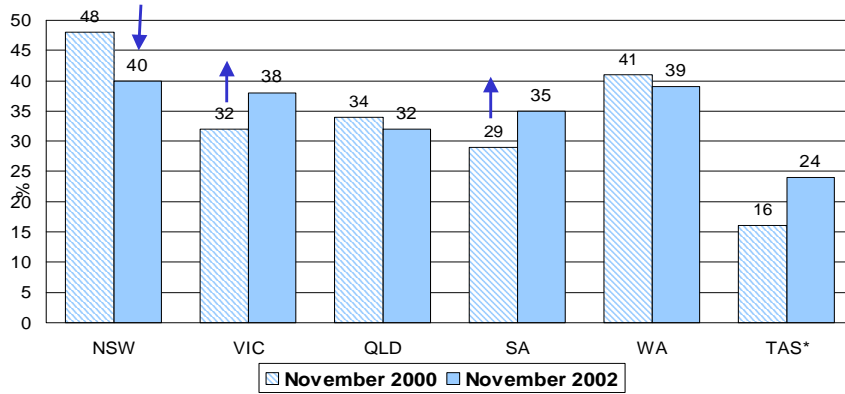

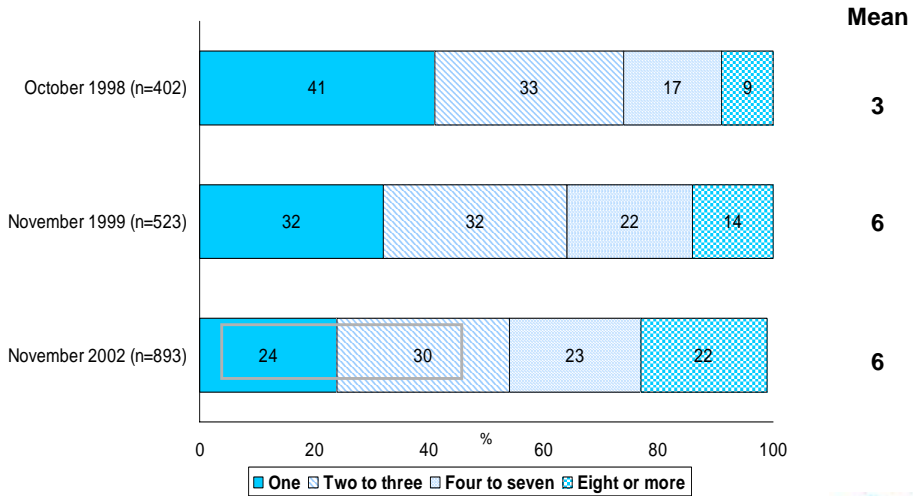

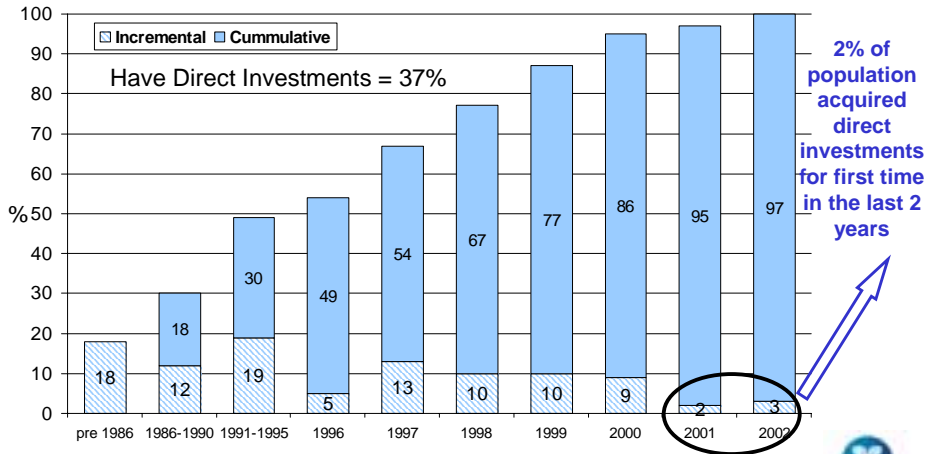

“Thinking only about your direct investments in shares, property trusts, options, warrants, futures or Interest Rates Securities. In which year did you first acquire any of these direct investments?”

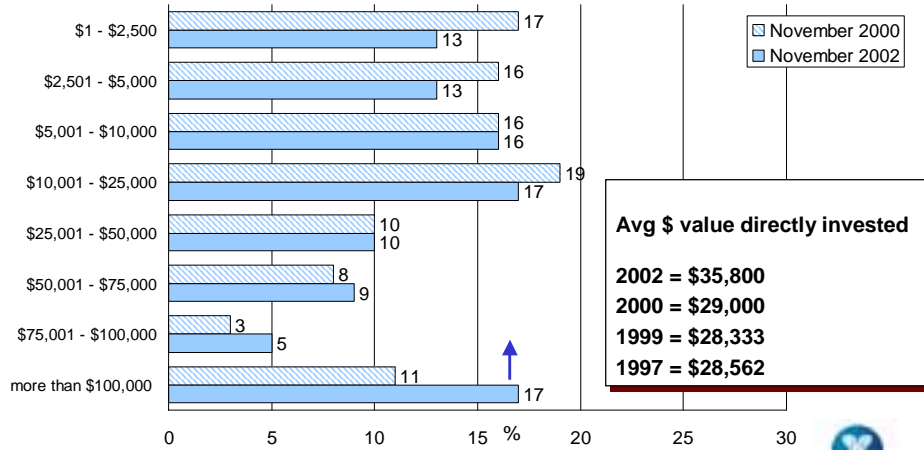

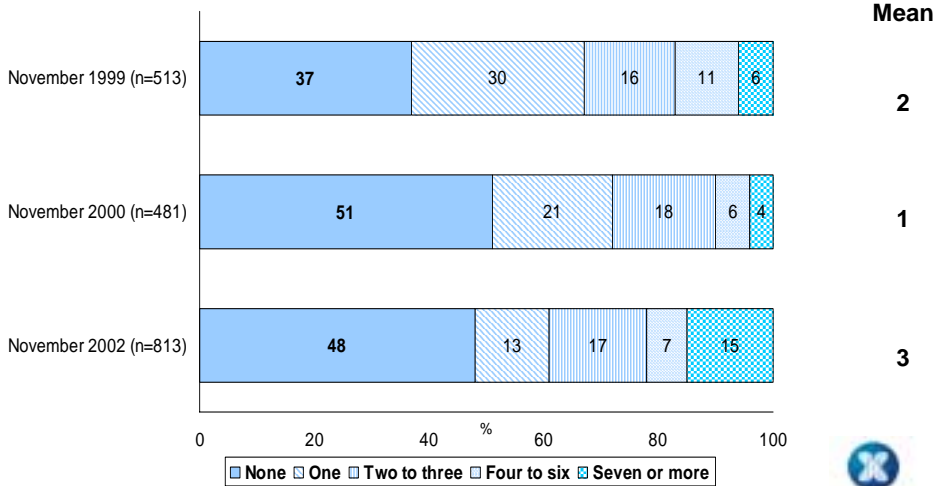

"In the last twelve months, approximately how many times have you bought or sold any direct investments in shares, property trusts, derivatives or Interest Rate Securities?"

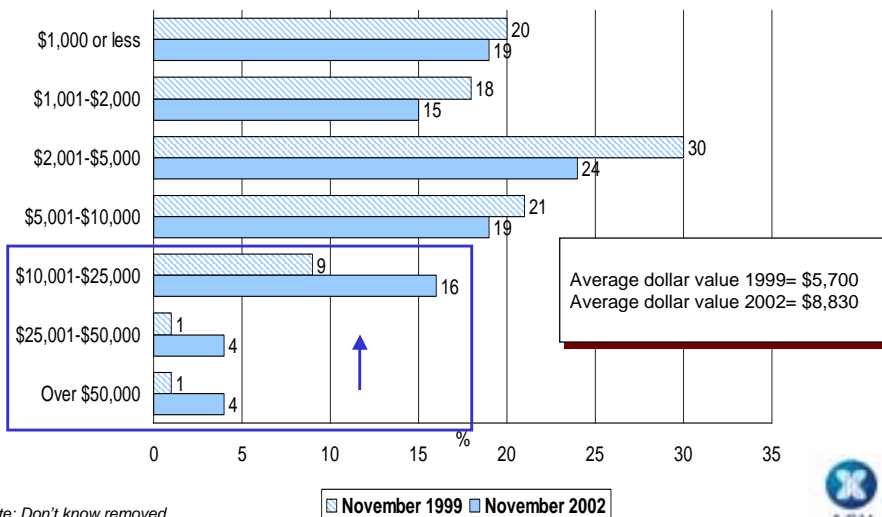

"In the last 12 months, what would be the average dollar value of the share parcels you have bought or sold?"



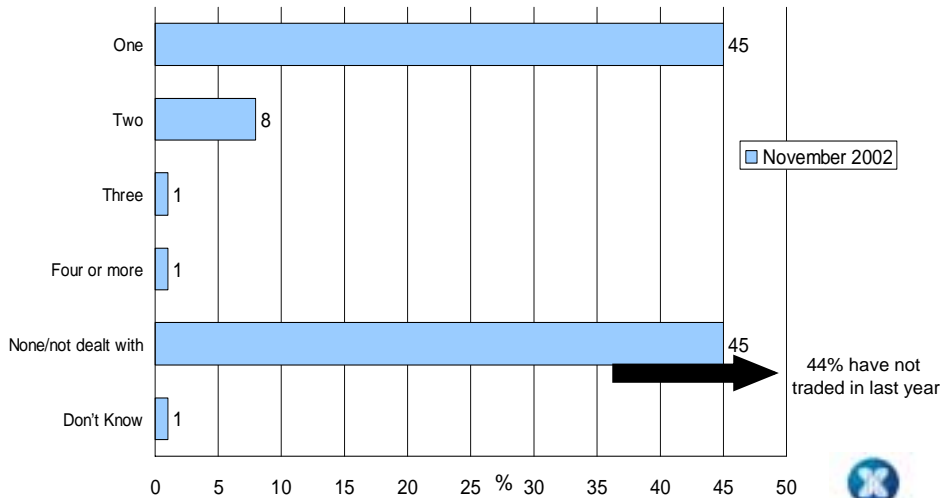

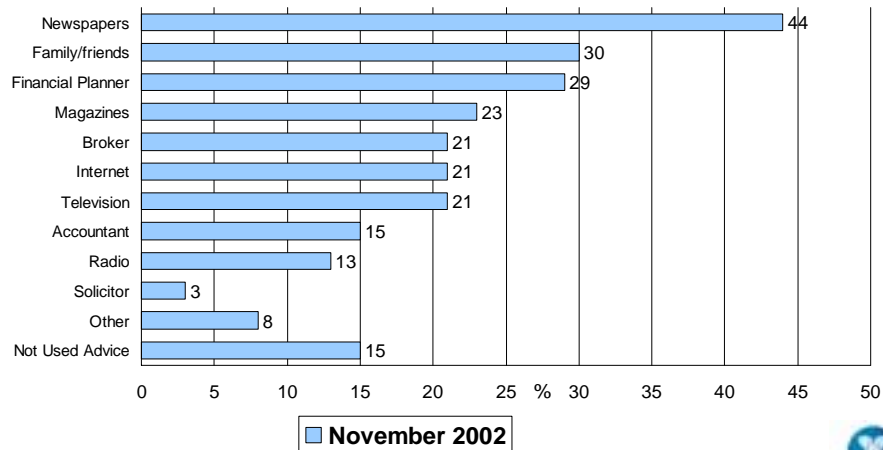

“Which of the following sources, if any, have you used to obtain advice and information about shares in the last two years?”

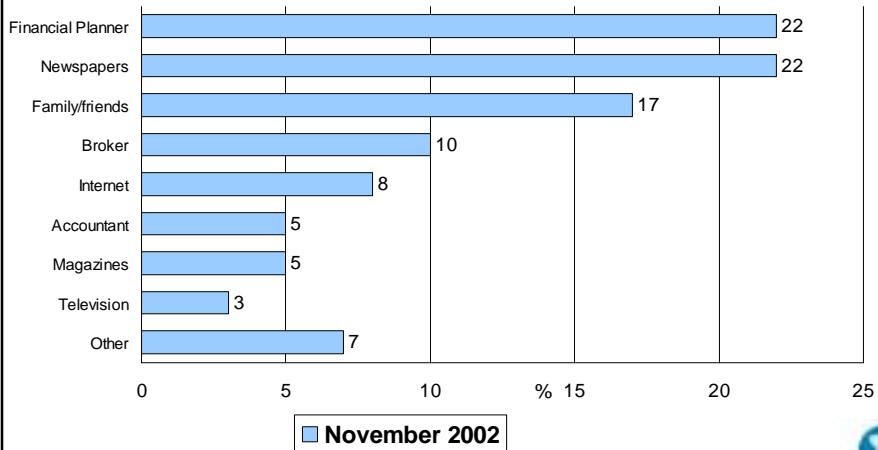

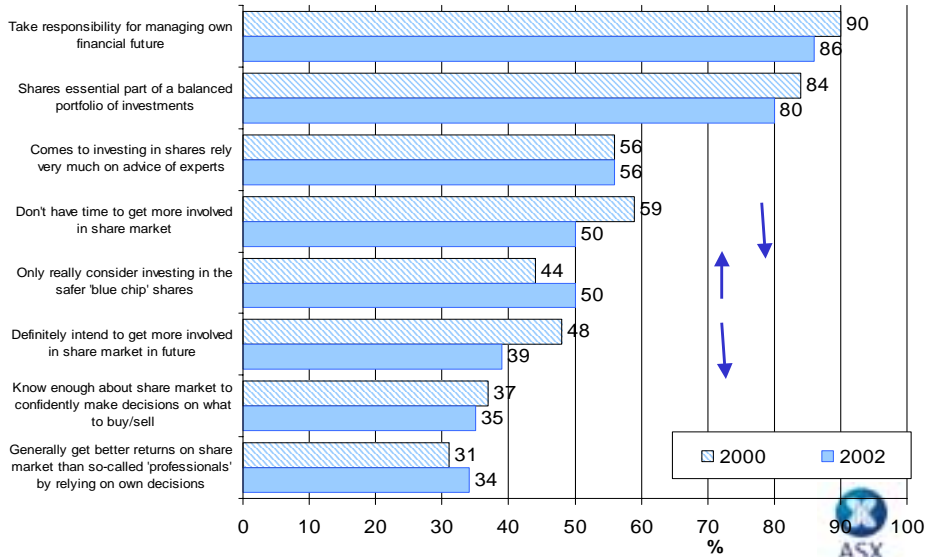

"Which of the following statements about shares & investments do you agree with?"



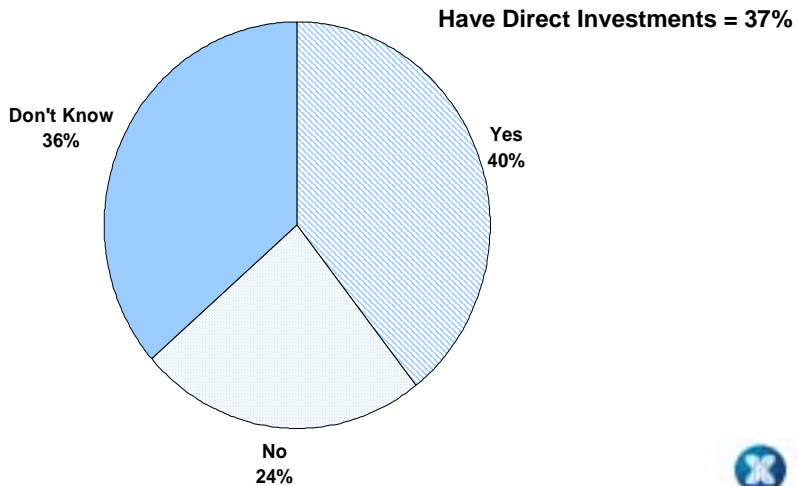

"Are you charged stamp duty when you buy or sell shares?"

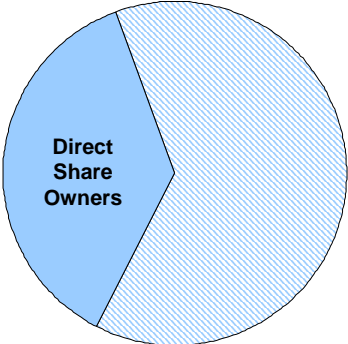

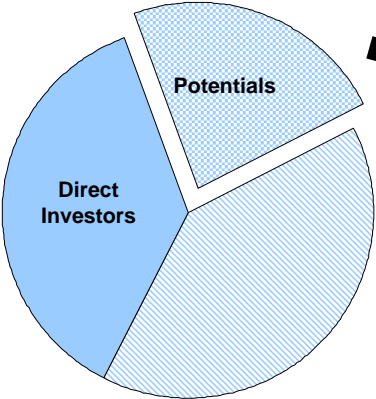

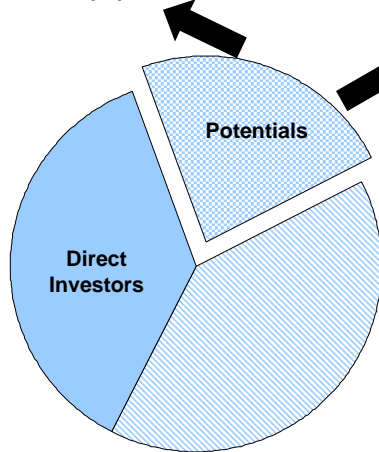
