ASX welcomes Calibre Group Limited

The Australian Securities Exchange (ASX) is pleased to announce that Calibre Group Limited listed at 12.00pm EST (10.00am WST) today, Thursday, 2 August 2012.

Calibre is an engineering services and project delivery group, servicing the mineral resources and infrastructure markets. Its ASX ticker code is CGH and its home branch is Perth.

The company raised \$75 million by the issue of 46,012,270 fully paid ordinary shares at an issue price of \$1.63, making it the largest new listing this financial year.

This is the fourth listing for Perth and the fifth listing nationwide this financial year, bringing the total number of ASX-listed entities with a Perth home branch to 893 and the total number of ASX listed entities to 2,206.
