**MEMORANDUM**

**SUBJECT:** Fletcher Challenge Forests Rights Issue

New Zealand Futures & Options Exchange has adjusted the Fletcher Challenge Forests equity options today in accordance with Contract Specifications for the Exchange Traded Equity Options Contracts (EQO).

As in the past the Exchange has adjusted Fletcher Challenge Forests share option contracts using the standard adjustment formulas (normally used for rights issues). The formula will result in the contract size of shares being increased and the strike price decreased as discussed below:

1. Adjustment to contract size:

The contract size will be increased using the "Contract Size Multiplier" (CSM) calculated as follows:

$$CSM = \frac{(m * WASP) + (n * WARP)}{(m * WASP)}$$

where:

m	=	number of FF shares held ex date
n	=	number of FF shares to be received ex date
WASP	=	average weighted share price of FF on ex day
WARP	=	average weighted rights price on ex day

The actual adjustment is set out below:
