ADDITIONAL D-CYPHA/SFE ELECTRICITY CONTRACT MONTHS TO BE LISTED

Effective Trade Date 24th June 2003, the SFE in conjunction with d-cyphaTrade will list two additional contract months for each of the d-cypha SFE Australian Electricity Futures Contracts. This change has been implemented to further enhance the ability for SFE Participants and their clients to trade the Electricity Strip contracts made available on the Sycom Trading platform.

The two outright futures contracts that the SFE will introduce are as follows – March 07 and June 07. The listing of these two contract months allows Base, Peak and Off-Peak 2007 Financial Year Strip Products to be listed.
