## **GREASY WOOL FUTURES CONTRACT JUNE 2003 EXPIRY INFORMATION**

This bulletin sets out important information for the next delivery period for the Deliverable Greasy Wool Futures contract commencing on Friday 13<sup>th</sup> June until Thursday 19<sup>th</sup> June 2003 regarding:

- AWEX Appraisal deadlines
- Tender documentation

### **AWEX Appraisal Deadlines**

The attached AWEX bulletin sets out the AWEX Appraisal and Certification deadlines for the next contract expiry.

### **Tender Documentation**

This is a reminder that it is the Clearing Participant's responsibility to obtain and provide SFE Clearing with **original** copies of the following documentation. Tender documentation can be lodged **both prior to and during** the delivery period.

#### **(1) Prior to Delivery Period:**

Prior to the actual commencement of the delivery period, on any business day Clearing Participants can lodge documentation for Safe Accommodation at SFE Clearing between 8.30am and 5.30pm. Providing that the documentation meets By-Law requirements, SFE Clearing will issue a Safe Accommodation Receipt (SAR) to the Clearing Participant and the wool will be admitted to Deliverable Stock. SFE Clearing will then hold the tender documents on behalf of the Clearing Participant and its Client.

#### **(2) During the Delivery Period:**

Tender documentation must be lodged on any business day within the delivery period prior to 12:30 pm, except on the final day of trading, when it must be lodged prior to 3:00 pm.

NB: During the actual delivery period, a Clearing Participant wishing to go to delivery, who has already obtained SAR(s) will only need to submit to SFE Clearing the SAR(s) accompanied by a Delivery Notification form.

## Warehouse Receipt

All the documentation above must be **original** copies. No faxed -documentation will be accepted. Any Clearing Participant attempting to submit copies other than the original documentation will be in default.

## General

All Clearing Participants with short and/or long positions must lodge with SFE Clearing an Ending Position Confirmation document everyday during the delivery period. The Ending Position Confirmation must be lodged with SFE Clearing by no later than **5:30pm** every day during the delivery period except on the last business day when it must be lodged by no later than **1:30pm**. Clearing Participants with short positions must also lodge a Delivery Notification on the day that they require a delivery to take place. These forms must be lodged with SFE Clearing by no later than 12:30pm on any day during the delivery period except for the last business day, where they must be lodged by no later than 3:00pm.

## **SYDNEY FUTURES EXCHANGE DEADLINES FOR CERTIFICATION 02/06/03**

The next contract delivery date is **Thursday 19 June 2003**.

As with previous contracts there is a five day delivery period.

Specific SFE appraisal is not required by the Australian Wool Exchange (AWEX) to issue an Appraisal Certificate.

Certification can be obtained based on the AWEX audit report of broker appraisals. Reports listing the sale lots traded through the AWEX auction system that are deemed eligible for SFE delivery are available by subscription from AWEX.

The Australian Wool Exchange must receive the *'Request for Issue of an Appraisal Certificate for Wool'* by the dates listed below. These requests should be sent directly to the Registrar.

**Southern Region:** Samples to be presented for appraisal in Melbourne.

**Western Region:** Samples to be presented for appraisal in Fremantle.
