China Magnesium Corporation Limited ("The Company") today issued 11,877,613 fully paid ordinary shares at \$0.30, which is a 62% premium to CMC's recent market price. The issue raised \$3,563,284.

The balance of approximately \$1M to complete the previously announced placement tranche of \$4.6M, is anticipated to be concluded on or before the acquisition of 100% of the issued shares in Ningxia Tianjing Tianda Metallurgical Smelting Co Ltd ferrosilicon plant in northern China (refer to CMC announcements dated 8 November 2011 and 23 February 2012).
