Amcom acquires Perth Data Centres

Amcom Telecommunications Limited (Amcom) (ASX:AMM), a leading telecom and IT Service Provider, today announced that it has entered into an agreement to acquire leading Data Centre provider aCure Technology Pty Ltd (aCure) for cash consideration of \$14.3m.

The aCure business is privately owned and operates 3 Data Centres in the Perth metropolitan area, servicing Corporate and Government customers. Following completion of the acquisition, Amcom will have a total of 7 Data Centres in Perth with a total capacity of 650 racks, all connected via Amcom's fibre network.

Commenting on the acquisition, Amcom's CEO Mr Clive Stein said "The ever expanding demand for Cloud and Hosted services is driving the requirement for us to expand our Data Centre footprint. As an established business, aCure's Data Centres enable us to quickly expand our capacity, rather than pursue a green field build strategy that is slower to market. With all 7 Data Centres directly connected to our fibre data network the opportunity to drive further revenues on the back of demand for Cloud services is substantial."

The completion of the acquisition of aCure is subject to the satisfaction of a number of procedural conditions precedent and is anticipated to settle in September 2013. The acquisition will be funded from existing bank facilities which has been increased to accommodate the acquisition and the maturity extended to December 2016. Post completion of the acquisition, the balance sheet will be conservatively geared* at 18%, with gearing reducing over time through strong free cash flow generated from growth in the annuity based earnings.

With the acquisition projected to complete by the end of the first quarter, the earnings contribution is expected to be positive after funding and integration costs, in FY15 over \$3m EBITDA contribution is expected, pricing the acquisition at an EBITDA multiple of circa 4.5 times.
