# **BOARD RESTRUCTURE UPDATE & CHANGE OF DETAILS**

A brief background on each new director follows:-

#### Jerko Zuvela

Jerko is a Chartered Professional Geologist having spent over 18 years in the mining and resources industry. Jerko is currently a director of ASX listed Dromana Estate Limited. He is a member of the Australasian Institute of Mining and Metallurgy (CP) and holds a Bachelor of Science in Applied Geology from Curtin University in Western Australia.

Ranko is a Chartered Accountant with over 25 years' experience in the areas of financial and executive management, accounting, audit, business and corporate advisory. Ranko has been a director and partner of Bentleys WA since July 2000.
