NOTICE UNDER SECTION 708A(5)(e)
CORPORATIONS ACT 2001 (CTH) and APPENDIX 3B

On 7 May 2015 Byron Energy Limited ("Byron or the Company") (ASX:BYE) announced a share placement including a conditional component subject to shareholder approval. At an EGM held on 19 June 2015 shareholders approved, inter-alia, the issue of up to 20,668,000 shares at \$0.25 per shares for the purpose of Listing Rule 7.1 and all other purposes and the issue of 3,748,000 shares to directors and/or their associates, also at \$0.25 per share.

On 1 July 2015 Byron advised the issue of 23,516,000 shares under the approvals obtained at the EGM on 19 June 2015.

Byron is pleased to announce the issue of a further 900,000 shares, on 3 July 2015, under the approvals obtained at the EGM on 19 June 2015. This now finalises the issue of 24,416,000 shares approved by shareholders at the EGM held on 19 June 2015, comprising (i) the issue of 20,668,000 shares at \$0.25 per shares for the purpose of Listing Rule 7.1 and all other purposes, and (ii) the issue of 3,748,000 shares to directors and/or their associates, also at \$0.25 per share.

In order to permit the on-sale of 900,000 placement shares issued on 3 July 2015 without the need for a disclosure document to be prepared under Part 6D.2 of the *Corporations Act 2001* (Cth) ("Corporations Act"), Byron makes the following statements for the purposes of compliance with sections 708A(5)(e) and 708A(6) of the Corporations Act:-

- a) the placement shares were issued without disclosure to investors under Part 6D.2 of the Corporations Act.
- b) this notice is being given under paragraph 5(e) of section 708A of the Corporations Act.
- c) as at the date of this notice, Byron has complied with the provisions of Chapter 2M (as they apply to Byron) and section 674 of the Corporations Act.
- d) as at the date of this notice, there is no excluded information (as defined in sections 708A(7) and 708A(8) of the Corporations Act).
