## **ASX Announcement**

### **Private Placement - Information required by ASX Listing Rule 3.10.5A**

Motopia Limited (Company) today announced a private placement of 227,438,462 shares in the Company (Shares) at \$0.0008 per Share raising \$181,950. Funds raised will be used for working capital purposes and to fund further development of the Company's ConvertU2 Online Platform and ConvertU2 Technologies Pty Ltd.

The 227,438,462 were issued pursuant to ASX Listing Rule 7.1A utilising part of the Company's 10% placement capacity approved at its 2014 Annual General Meeting. In accordance with ASX Listing Rule 3.10.5A the following information is provided to the ASX:

1. The issue of 227,438,462 shares pursuant to ASX Listing Rule 7.1A raised \$181,950 and diluted the voting power of existing shareholders by 4.64%.
2. The Company elected to issue the Shares as a placement under Listing Rule 7.1A rather than a pro rata issue (or other type of issue) due to the cost and timing benefits of a private placement.
3. There was no underwriting agreement in connection with the placement.
4. The Company incurred capital raising commission fee equal to 8% of funds raised.
