Placement raising \$250,000

Canberra – Thursday 26 November 2015: XTEK Limited (ASX:XTE; XTEK or Company) is pleased to announce that it has drawn down \$250,000 under the \$10 million Equity Placement Facility entered into with Kentgrove Capital GrowthTech Fund (Kentgrove), details of which were announced to the market on 15 July 2015.

In satisfaction of the draw down amount, the Company has issued 561,798 new securities in the capital of the Company to Kentgrove at an issue price of \$0.445 per share. The funds raised will be applied towards commercialising XTclave™, developing commercial UAS solutions and for working capital purposes.

Following the allotment and issue of the 561,798 new securities, the issued capital of XTEK will comprise 21,914,031 fully paid ordinary shares, with 500,000 unlisted options currently on issue.
