## **ASX Announcement**

### **Private Placement - Information required by ASX Listing Rule 3.10.5A**

Motopia Limited (Company) today announced a private placement of 220,204,290 shares in the Company (Shares) raising \$141,000 before costs. Funds raised will be used for working capital purposes and to fund further development of the Company's products.

Of the 220,204,290 Shares issued, 123,591,090 Shares were issued pursuant to ASX Listing Rule 7.1A utilising part of the Company's 10% placement capacity approved at its 2015 Annual General Meeting. The balance (96,613,200 shares) were issued under ASX Listing Rule 7.1. In accordance with ASX Listing Rule 3.10.5A the following information is provided to the ASX:

1. The issue of 123,591,090 shares pursuant to ASX Listing Rule 7.1A raised \$92,693 and diluted the voting power of existing shareholders by 2.12%.
2. The Company elected to issue the Shares as a placement under Listing Rule 7.1A rather than a pro rata issue (or other type of issue) due to the cost and timing benefits of a private placement.
3. There was no underwriting agreement in connection with the placement.
4. The Company incurred capital raising commission fee equal to 8% of funds raised.
