Velpic signs MOU with Tikforce to enhance eLearning capabilities

Following completion of the lesson, Velpic's platform will automatically feed the results into TikForce's qualification database. This will help to generate a more complete profile of the employee and can be utilised to reduce on-boarding time for employers. In addition to providing

easy identity verification and bio-metric confirmation during the delivery of training TikForce can also provide a sales channel for online assessments.

A revenue sharing arrangement is being considered and will include Velpic and TikForce each charging a Per Transaction fee, with Velpic to charge a fee for each lesson completed and TikForce to charge a fee for each verification.

The integration of TikForce's technology will expand the capabilities of Velpic's eLearning platform to encompass an employee identity verification option, and provide a distinct competitive advantage over other Learning Management System providers.

Velpic Chief Executive, Russell Francis, commented:

"We are very excited to be working with TikForce and incorporating their identity verification technology into the Velpic eLearning platform. Its been a nagging criticism of the eLearning market place that employers may not be able to verify 100% who actually completed the lesson and now Velpic can lead the industry with this innovative solution. The combination of technologies will make for a very compelling product for businesses with high regulatory demands on their training. This is also just the first of many potential opportunities from a partnership with TikForce"

TikForce Chief Executive Kevin Baum commented:

"Velpic provides a leading training and assessment platform, which makes them an ideal partner for the rollout of TikForce's online training and assessment ID integration.
