RCR AWARDED \$108M IN NEW CONSTRUCTION CONTRACTS

Diversified engineering and infrastructure company RCR Tomlinson Ltd (ASX: RCR) is pleased to announce that it has been awarded new construction contracts valued at approximately \$108 million.

MMG Limited, Dugald River Project

A contract with MMG Limited ("MMG") for the construction of a processing plant at MMG's Dugald River project which is subject to MMG finalising financing arrangements on the project. The contract is valued at approximately \$73 million and work will commence immediately and is scheduled for completion in October 2017.

RCR's scope of work includes project management, fabrication and supply of various structural steel, mechanical and E&I components, construction (SMP and E&I) and commissioning support for a zinc and lead concentrator and associated plant, at MMG's Dugald River project near Cloncurry in Queensland.

MMG are responsible for the plant design and the supply of the key processing equipment. MMG is a mid-tier, global producer of base metals with operations in Peru, Australia, the Democratic Republic of Congo and Lao PDR.

Rio Tinto, Cape Lambert Power Station

A contract with Rio Tinto for the construction and commissioning of Rio Tinto's Cape Lambert Power Station, valued at approximately \$35 million.

RCR will use its in-house engineering and extensive experience in the delivery of large power station projects throughout Australasia to complete this project for Rio Tinto.

RCR's scope of work includes overall project management, construction (SMP/E&I and minor civil works) and commissioning of an 80 MWe Open Cycle Power Plant, at Rio Tinto's Cape Lambert Iron Ore Operation in Western Australia. Work will commence immediately and is scheduled for completion in October 2017.

The design and procurement of major equipment items for the power station will be supplied by Rio Tinto.

RCR's Managing Director & CEO, Dr Paul Dalglish said, "RCR will utilise our turnkey capability in the Resources and Energy sectors and our integrated approach to engineering and construction for successful delivery of these projects."

"The project for MMG builds on our position as a leader in the construction of major minerals processing plants. We are looking forward to working together with MMG and the local community to successfully deliver these construction works."

"The Cape Lambert project is the first win of an improving pipeline of opportunities that we are seeing in the power generation sector. We are currently preferred on a number of other large power projects including gas and solar power stations that are under negotiation. We are pleased to continue our valued relationship with Rio Tinto through this project."

"Pleasingly, these awards follow our recent announcement of \$130 million in new contracts and further boosts our order book for FY17."
