## **ChimpChange Limited ACN 150 762 351 – Pre-Quotation Disclosure**

The following information is provided to ASX for release to the market in connection with the official quotation and deferred settlement trading of the fully paid ordinary shares in ChimpChange Limited (**Company**).

Capitalised terms which have not otherwise been defined in this document have the meaning given to them in the Prospectus lodged with the Australian Securities and Investment Commission dated 30 May 2016 (**Prospectus**).

### **1. Close of Offer and receipt of funds**

The Offer under the Prospectus closed on 24 June 2016 and the Company has issued, on 30 June 2016, 18,750,000 fully paid shares at an issue price of \$0.80 per share.

The Company confirms that it has received cleared funds for the complete amount of the issue price of every share issued and allotted shares to successful applicants.

### **2. Shareholder spread**

The distribution schedule of shareholders is set out in **Attachment A** and a statement of the 20 largest shareholders is set out in **Attachment B**.

The Company advises that, excluding restricted securities:

- (a) the Company has at least 300 holders of securities who have a parcel of shares with a value of at least \$2,000; and
- (b) at least 50% of ordinary shares in the Company are not held by related parties.

### **3. Issue of Shares**

The number of Shares issued under each component of the Offer is:

- (a) Broker Firm Offer – 7,088,500;
- (b) Institutional Offer – 9,387,500; and
- (c) Chairman's List Offer - 2,274,000.

### **4. Basis of allocation of Shares and procedure for determining allocations**

The basis of allocation of ordinary shares under the Offer for each component of the Offer was as follows:

- (a) Broker Firm Offer – allocation of securities to applicants under the Broker Firm Offer has been determined by Brokers who allocated securities among their respective clients. Applicants under the Broker Firm Offer should confirm their allocations by phoning their Broker;

- (b) Institutional Offer – The allocation of securities to applicants under the Institutional Offer has been determined by the Joint Lead Managers and the Company during the bookbuild, and institutional investors have been notified of their allocations; and
- (c) Chairman's List Offer - The allocation of securities under the Chairman's List Offer has been determined by the Company in consultation with the Joint Lead Managers, and successful Applicants have been notified of their allocations.
