Mach7 Selected by Large U.S. University Medical Centre

Summary

- 5-year software licence providing contracted revenues in excess of US\$800,000
- Mach7 technology selected for its technical superiority and extensive flexibility

Melbourne, Australia – 2 August 2016: Mach7 Technologies Limited (**Mach7**) (ASX:**M7T**) is pleased to announce it has signed a 5-year license of Mach7 Enterprise Imaging Platform software to a large U.S. University Medical Centre.

Under the terms of the 5-year software license agreement, Mach7 will earn in excess of US\$800,000 in contracted revenues. The majority of this contract value is expected to be recognised as revenue this calendar year upon the software being delivered and installed at the University Medical Centre. Additionally, Mach7 will earn a guaranteed annual support fee for at least five years, increasing its growing annual support fee revenue stream.

The University Medical Centre performs more than 20,000 surgeries each year and generates more than US\$2 billion in annual revenue. Mach7 is unable to disclose the name of the customer at this time.

The compelling value proposition of Mach7 Enterprise Imaging Platform was reinforced by the customer, who said Mach7 was chosen ahead of its competitors because of its technical superiority, extensive flexibility and immediate benefit to the enterprise without the significant investments in custom coding that other solutions would have required.

The flexible and robust tool set offered by Mach7 Enterprise Imaging Platform is an "off-the-shelf" solution that enables highly specialised workflows previously unavailable to customers. In addition to basic routing and pre-fetching functionality, these workflows allow customers to immediately improve clinical operations and patient outcomes, while reducing costs for the enterprise.
