# RINCON PROJECT JV AGREEMENT EXECUTED

*Rincon Lithium Project is located in the "Lithium Triangle" in Salta Province, Argentina*

## HIGHLIGHTS

- **Definitive Farm-In Joint Venture Agreement executed for the Rincon Lithium Project.**
- **Argosy will now commence earning up to a 90% interest in the Argentinian joint venture company currently being established.**

Argosy Minerals Limited (ASX: AGY) ("Argosy" or "Company") is pleased to advise that, following receipt of shareholder approval (as announced on 16 September 2016), it has executed the definitive Farm-In Joint Venture Agreement ("Agreement") for the Rincon Lithium Project with Mr Francisco Menendez and Mr Pablo Alurralde (the "Vendors").

Argosy Director, Jerko Zuvela commented "The Agreement signifies our intent to fast-track development of the Rincon Lithium Project and reinforces the strong relationship with our partners. Together, our aim is to build a credible and substantial lithium development and production venture."

The execution of the Farm-in Joint Venture Agreement sanctions the Company and the Vendors to establish an Argentinian joint venture company (the "JV Entity") to own the Rincon Lithium Project in Salta Province, and the Company will have the right to earn up to a 90% interest in the JV Entity.

Argosy has commenced legal and administrative works to establish the JV Entity, and expects this to be completed within 30 days.

Argosy will progressively earn an increasing interest in the Project subject to meeting performance milestones associated with funding the development of the Project.
